NOTIFICATION

It is notified for the information of all concerned that on the request of students, the Vice-Chancellor, in anticipation of the approval of the Academic Council, has accord permission to grant a special chance to the students, who were registered in their M.Phil/Pre Ph.D Course in the academic session 2009 to 2014 but could not complete their respective courses with in admissible period/chances which would be subject to fulfilment of the following conditions:-

- i. This special chance shall only be admissible to the students of M.Phil/Pre Ph.D who could not complete their degree and were registered for this course for the period from **2009 to 2014**.
- ii. Those students who were registered for M.Phil./Pre. Ph.D. course after the Academic session 2013-14 shall not be entitled for this special chance.
- iii. For this special chance, a fee of Rs. 5000/- each examination shall be chargeable.
- iv. The special chance is admissible only to complete the degree for the students who have reappear in one or more papers and not for improvement of marks/division.
- v. For this Special Exam. the Centre(s) of examinations shall be at Rohtak only.
- vi. The examinations for this special chance shall be got conducted in July/August, 2017.

The examination form along with fee shall be filed up through online mode **latest by 20.7.2017 from the portal of concerned department where student get themselves enrolled during the period 2009-2014**.

No examination form will be entertained/accepted after the cutoff date as 20.7.2017. The schedule of examination/declaration of result will depend on administrative requirements and the students will have no claim for early conduct of examination as well as declaration of results. If any **INELIGIBLE** candidate submits his/her online examination form, they will be responsible for that and the examination fee will not be refunded to such students.
